

CERTIFICATE OF INTERMENT

That this conveyance, and all right, title, and interest hereby conveyed in the property above-described, is subject to all laws and ordinances, and to the following conditions, reservations, restrictions and rules and regulations, and the Grantee covenants and agrees that:

a. The Grantor reserves to itself, and to those lawfully within the Cemetery, the perpetual right of ingress and egress over the above-described real property for the purpose of caring for the same and for passage to and from other burial sites.

b. No transfer, conveyance or assignment of any interest or rights acquired by Grantee shall be valid without a written consent of Grantor and being thereafter recorded on its books.

c. No monuments or other memorial, tree, plants, objects or embellishments of any kind shall be placed upon, altered or removed from the above-described property by the Grantee without the written consent of Grantor. All grading, landscape work and improvements of any kind, and all care on the above described property, shall be done, and all trees and plants of any kind shall be planted, trimmed or removed and interments disinterments and removals, including all openings and closing of graves, shall be made only by Grantor with proper equipment. All interments shall be made subject to the use of the type of and outer container as shall be designated by Grantor in its rules and regulations.

d. Grantor, at the expense of Grantee and as a charge against the above-described property, may repair or remove any monument or other memorial which is improper or offensive or which has become dangerous or dilapidated; and may remove any tree, flower or plants, or other object or embellishment that becomes unsightly or dangerous.

e. Grantor shall not be liable for loss or damage caused by an act of God, common enemy, thieves, vandals, malicious mischief makers, unavoidable accidents, riot, or order of any military or civil authority.

f. The enumeration herein of certain conditions, reservations, restrictions and rules and regulations shall not be construed as the only limitations, but the Grantee shall always hold all his interest and rights limited by and subject to the rules and regulations and by-laws of Grantor now existing or which may be by it hereafter adopted either by amendment, alteration or the adoption of new ones. These rules and regulations are on file for inspection in Grantor's office and are specifically referred to and herein inserted as if set forth in full.
